NATURAL TECHNIQUES

There have always been natural techniques for extending life. It is highly likely - although wherever they are they intend to remain hidden - that there are people who have lived here for thousands of years using ancient yoga techniques. They generally believe that they have a duty to stay on Earth and subtly guide humanity. You are not going to find them.

For example, you would need to live over 3600 years to calculate - from observation - the precession of the equinoxes. We do not live that long. However, someone did because we know about the precession of the equinoxes.

MONO ATOMIC GOLD

Mono Atomic Gold is the publicly discussed method which is claimed to allow a person to live physically forever. Obviously, if there was not some "catch", everyone would be living forever. Literature suggests that special techniques are required to both prepare and ingest this substance to get the desired effects and it is not uncommon for all this to be dismissed as quackery.

However, there are scattered reports of people who got the technique right and cannot die. Reports suggest that these people become unhappy and regret what they did. Now they long for "the end". However, the process, if done correctly, reportedly is not reversible.

DISCOVERIES LEADING TO CONTROLLED REINCARNATION

In more recent times, coinciding with the belief that accumulation of material wealth is the purpose of human life, the wealthy have become concerned that they will die someday and "you can't take it with you". However, if you could defeat death, you could lie around all day gazing at all your possessions and the status and power they represent in a world where materialism is the dominant philosophy.

So, if you wanted to use your wealth to buy something, everlasting life would be the most valuable thing you could buy.

This motivation led to various research projects and discoveries which we will now discuss.

Robert Monroe was a man who found that he could Astrally project at will. This experience was initiated by some accident as opposed to some type of meditation practice or similar technique. It was totally unexpected and Monroe did not know what had happened or where he was. Since he had no Spiritual training or discipline - and rejected such things - he was an ideal subject for government experiments. He actually believed he had "invented" Astral projection - discovered "new worlds" that no one had ever seen before. He was totally unaware that people have been Astrally projecting since people have existed or that anyone can train themselves to do this.

Actually, he had never heard the phrase "Astral projection" and so invented his own nomenclature system and invented the phrase "out of body experience".

CONTROLLED REINCARNATION

Seeking an explanation, he willingly worked with the scientific community (scientific atheists). They tested him. In one test, they put him in a Faraday cage and told him to project. He did, but found he could not escape from the cage because electricity - which is invisible in the Physical dimension - is both visible and solid in the Astral dimension. So, he was trapped in a "net" and could not escape.

REGRESSION TECHNOLOGY

Regression technology is performed using a device obtained from the alien exchange program. No earth scientist created it. It is capable to regress a person at any age far enough back in time to be simply a fetus. So, it can make the old young again. The original device is said to have alien symbols above the controls with tape over them on which was written the equivalent in our language. Of course, it was reverse engineered

and now is a common gadget in areas where only those with high security clearances are permitted.

CONSCIOUSNESS TRANSFERENCE

Consciousness transference can be done naturally by adepts. However, devices exist that can accomplish the same thing using machines that anyone can operate regardless of their psychic skills.

CLONING

Cloning is the current method of life extension. The old person simply transfers his/her consciousness to a clone at a younger age. State of the art facial recognition technology can detect this.

GENETIC MODIFICATION TECHNOLOGY

Cloning will likely be replaced with genetic modification technology. Researchers at Ft. Detrick have determined that aging is caused by DNA strands developing "split ends" over time - sort of like hair. They have perfected a technique to stop this process. A young person treated with this process will age naturally to between 22 and 25 years old. The aging process will then stop and they will remain at that age indefinitely.

Of course, older people can be regressed to the appropriate younger age and then the process can be applied to them.

SOUL CAPTURE AND STORAGE

We know from the video interview on you tube "A Rothschild Speaks Out" by project Camelot that the government can extract Souls from bodies and hold them prisoner using special containment fields and then insert them into a new body "when they are needed again".

OPINIONS OF MASTERS AND GURUS

Masters and Gurus do not recommend using life extension technologies of any kind. Of
